MODEM COMMUNICATION PARAMETERS

The modem communications parameters are:

- 300, 1200, or 2400 bps
- 7 data bits
- even parity
- 1 stop bit
- Asynchronous

The modem complies with Bell 212A/103 and CCITT V.22 standards.

The LRC (Longitudinal Redundancy Check) is always the last character of the message. This character is the Exclusive OR of all characters in the message, starting with the first character after the STX, through and including the ETX.

The maximum length of a typical transmitted message cannot exceed 512 bytes including the STX, ETX, and the LRC.

For terminal software versions that support large message buffers the maximum length of a transmitted message cannot exceed 2000 bytes including the STX, ETX, and the LRC. For protocol problems "Terminal ACK Not Received By Host" and "Terminal Does Not Acknowledge Response From Host" the 3-second timeout counter should start **after** the LRC is transmitted from the MODEM.

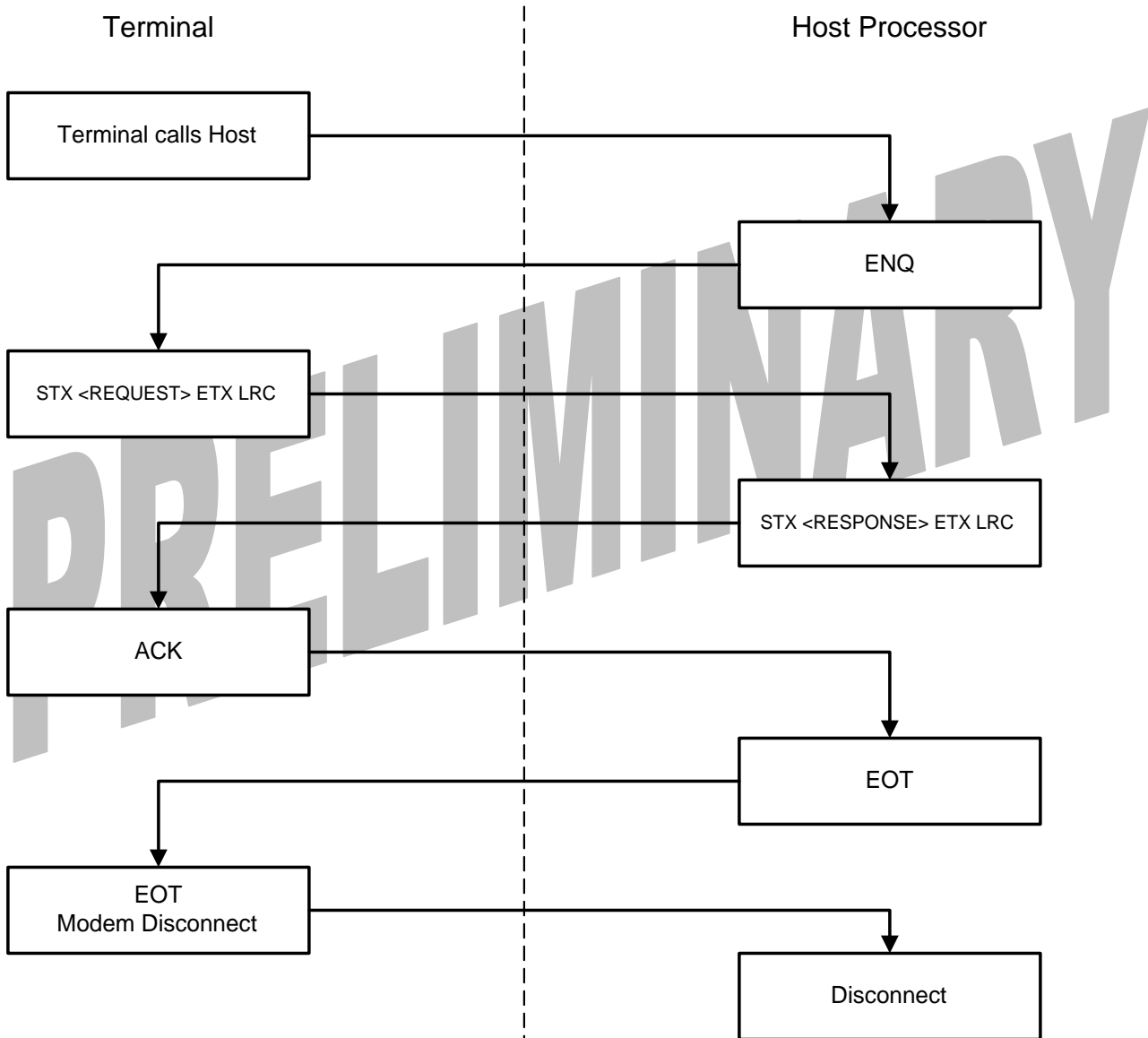
The Triton terminal communications protocol closely follows the VISA II POS Authorization protocol. The following diagrams illustrate the protocol level for messages sent between the terminal and the processor.

Diagrams are provided for the two modes of normal operation (terminal expects EOT, and terminal does not require EOT), as well as conditions that result in cancelled transactions.

Normal Message w/EOT

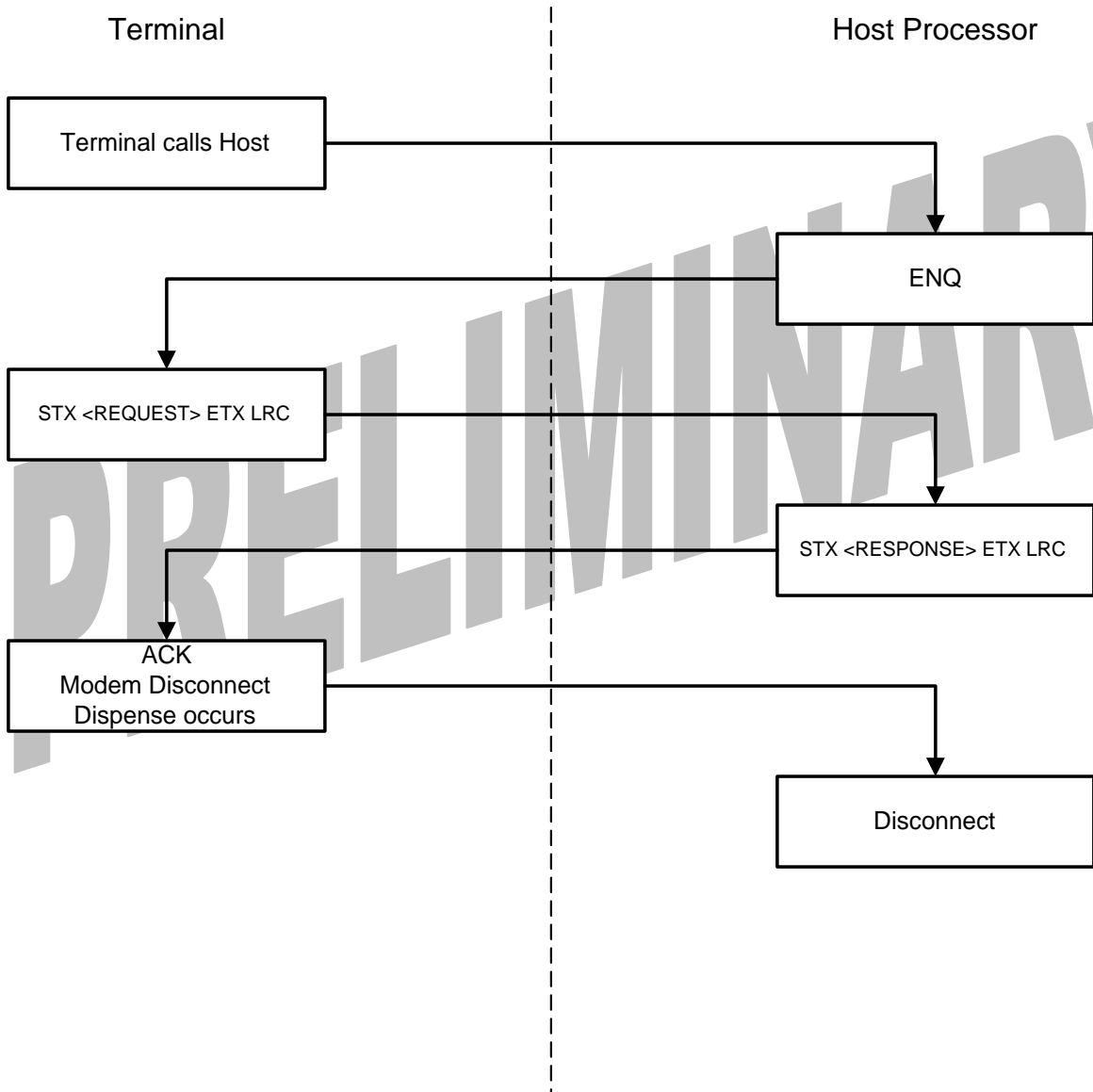
This diagram illustrates the line protocol for a normal dispense cycle. Dispense occurs after Host EOT is received (default).



In this mode, the terminal will not dispense unless it receives the EOT from the host.

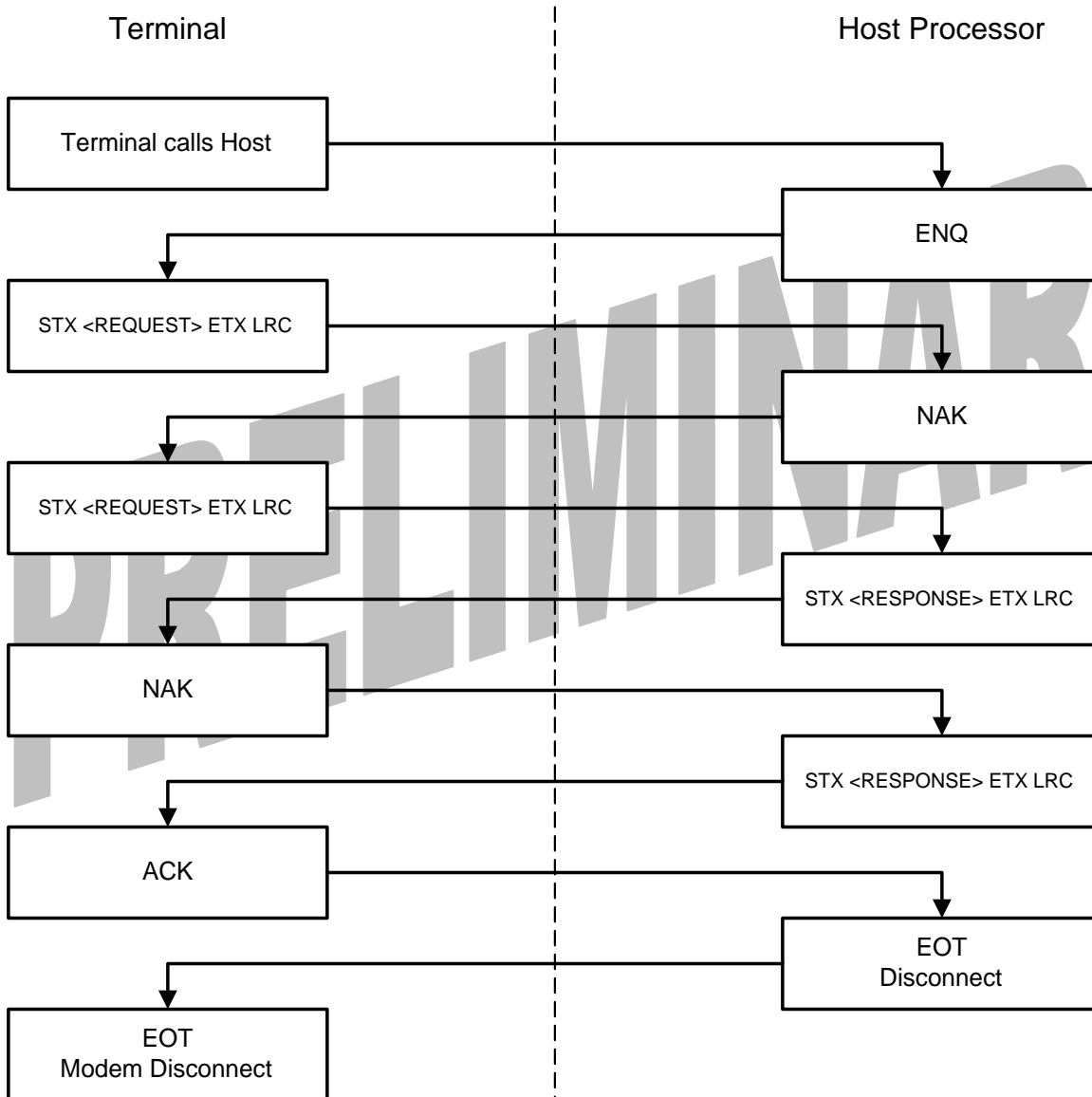
Normal Message w/o EOT

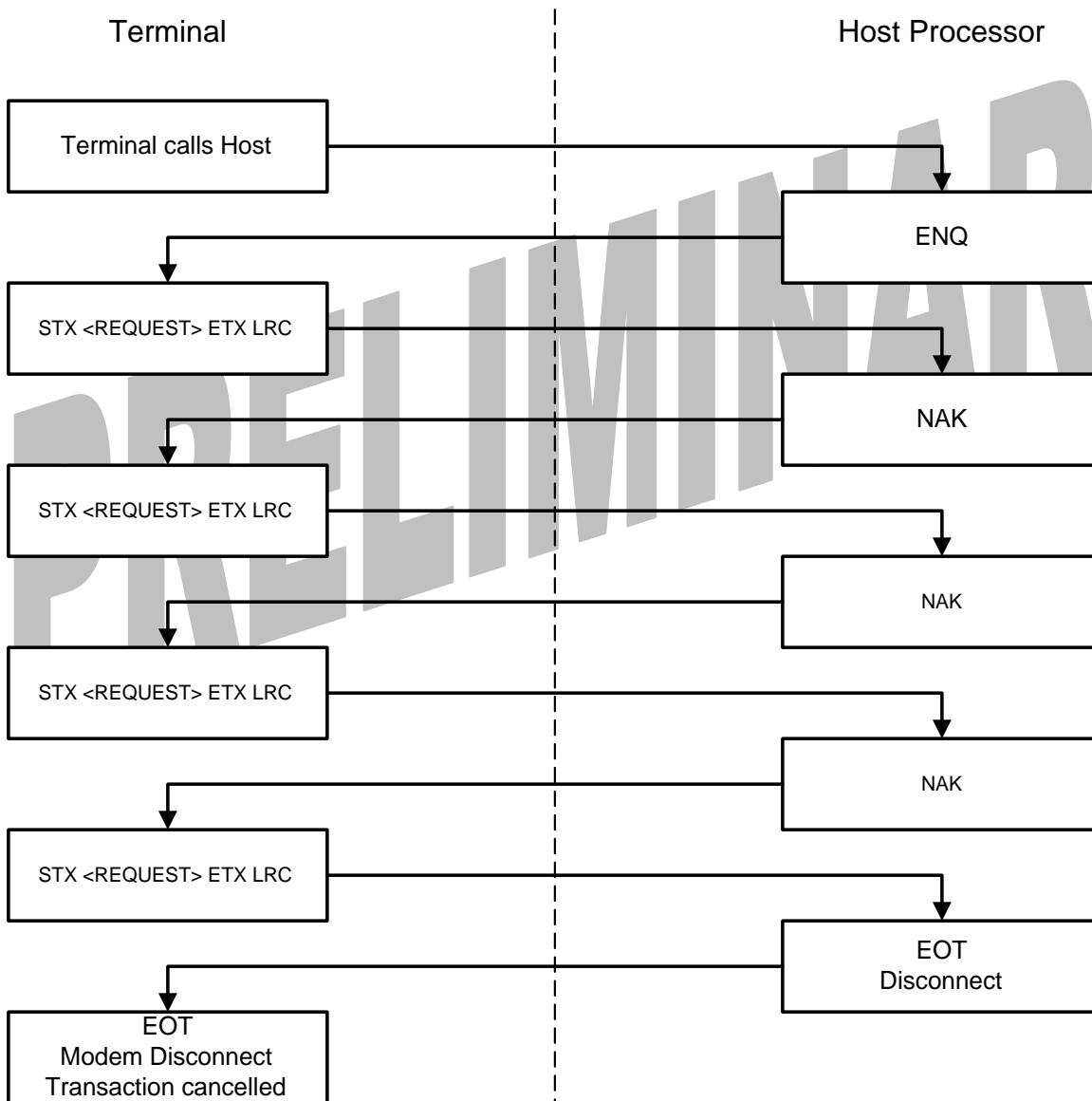
Correctable Request and Response Transmit Error

This diagram illustrates the line protocol for a correctable transmit error in the request and response messages. The NAK character is sent to indicate an error in the LRC.



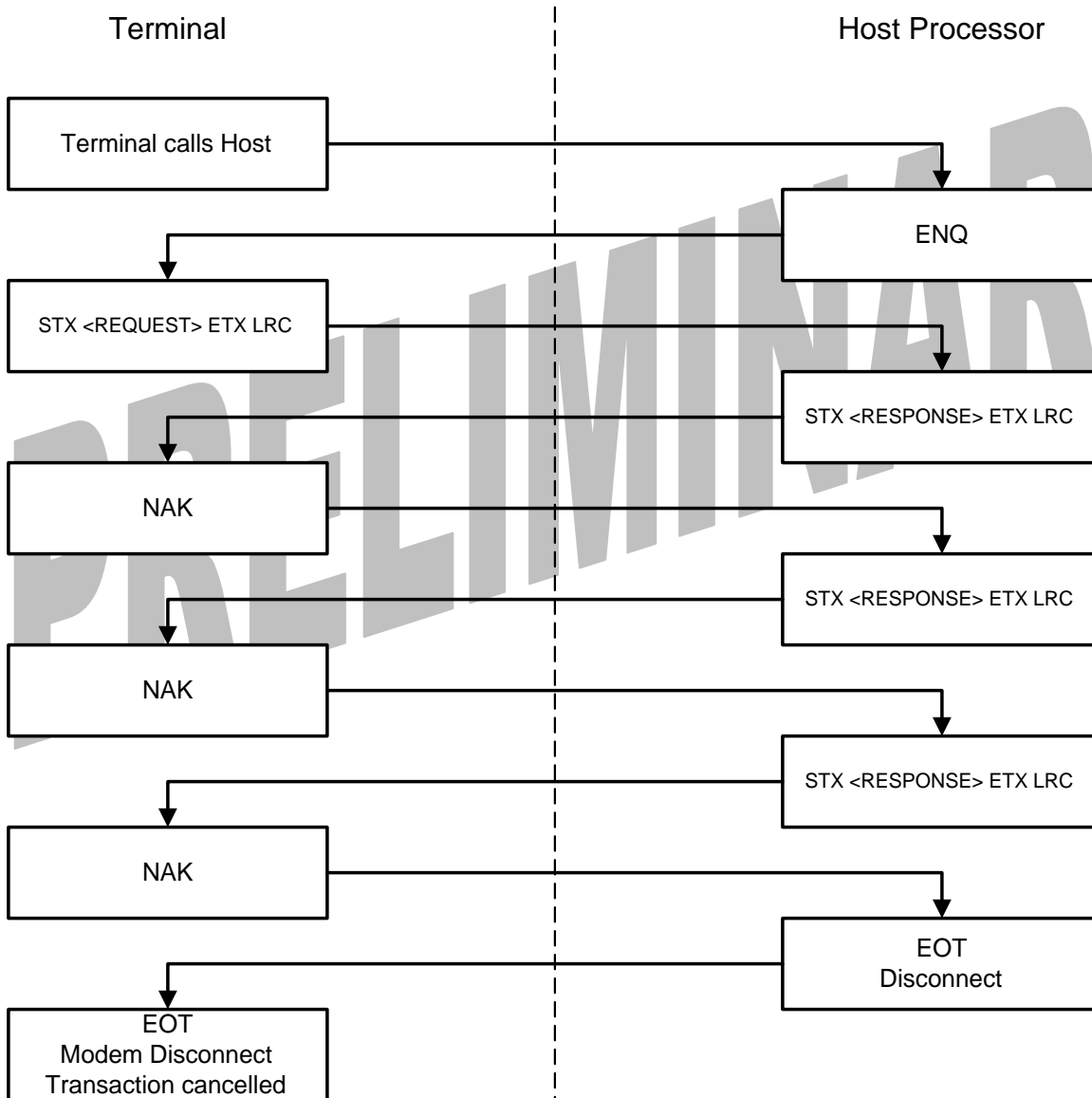
Uncorrectable Request Transmit Error

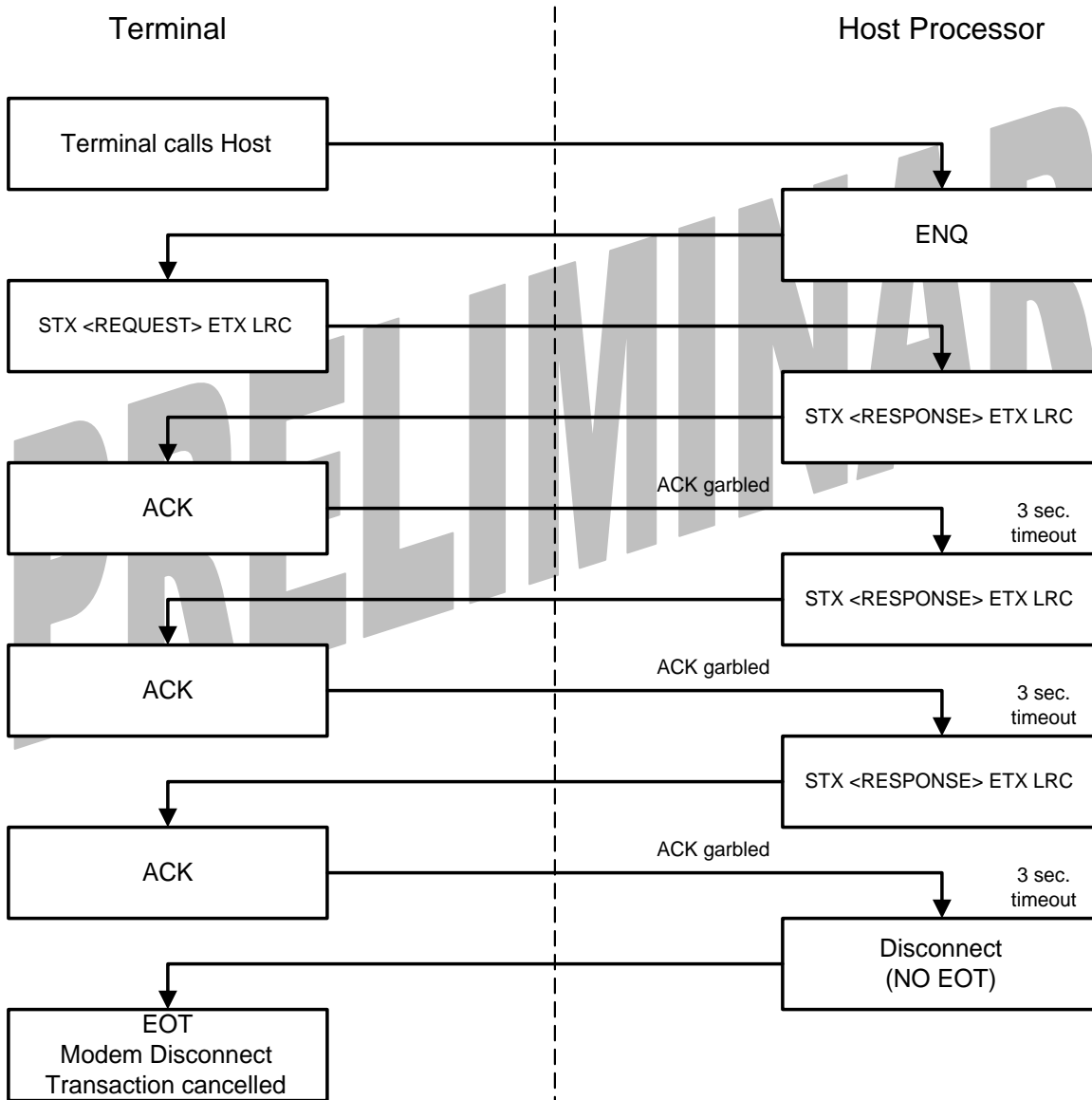
Uncorrectable Response Transmit Error

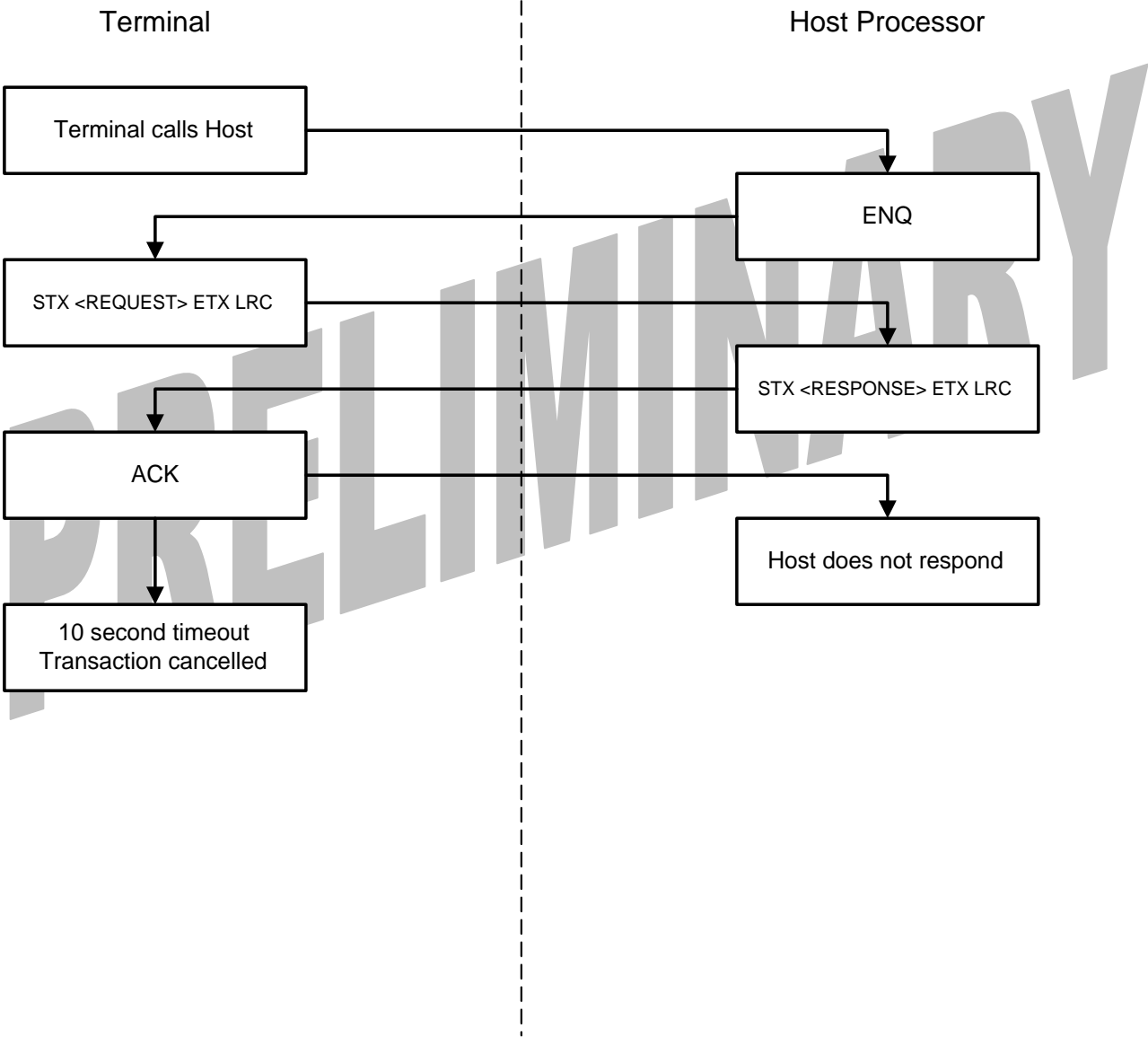
Terminal ACK Not Received By Host

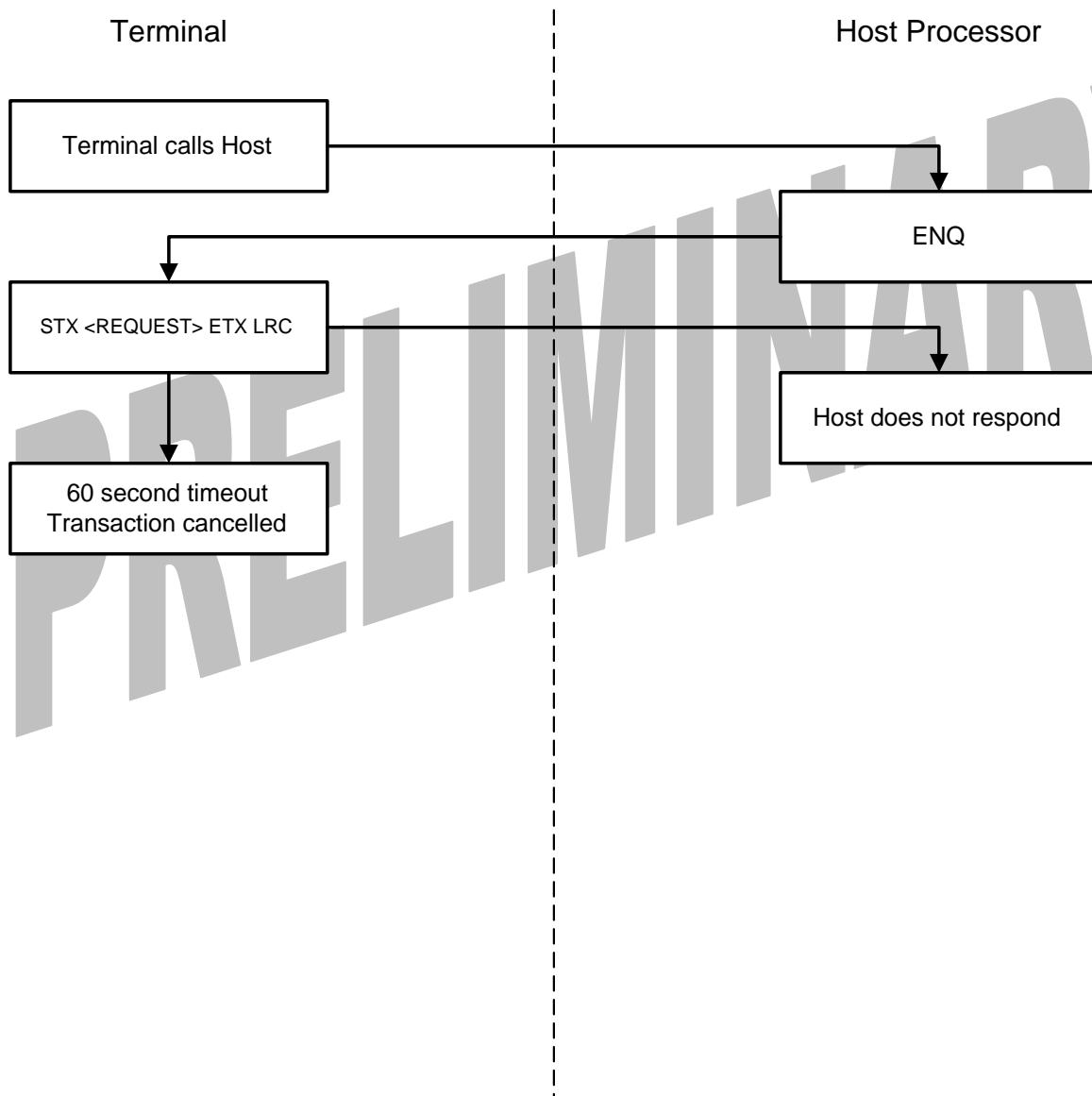
Host Does Not Respond to ACK from Terminal (Default Mode)

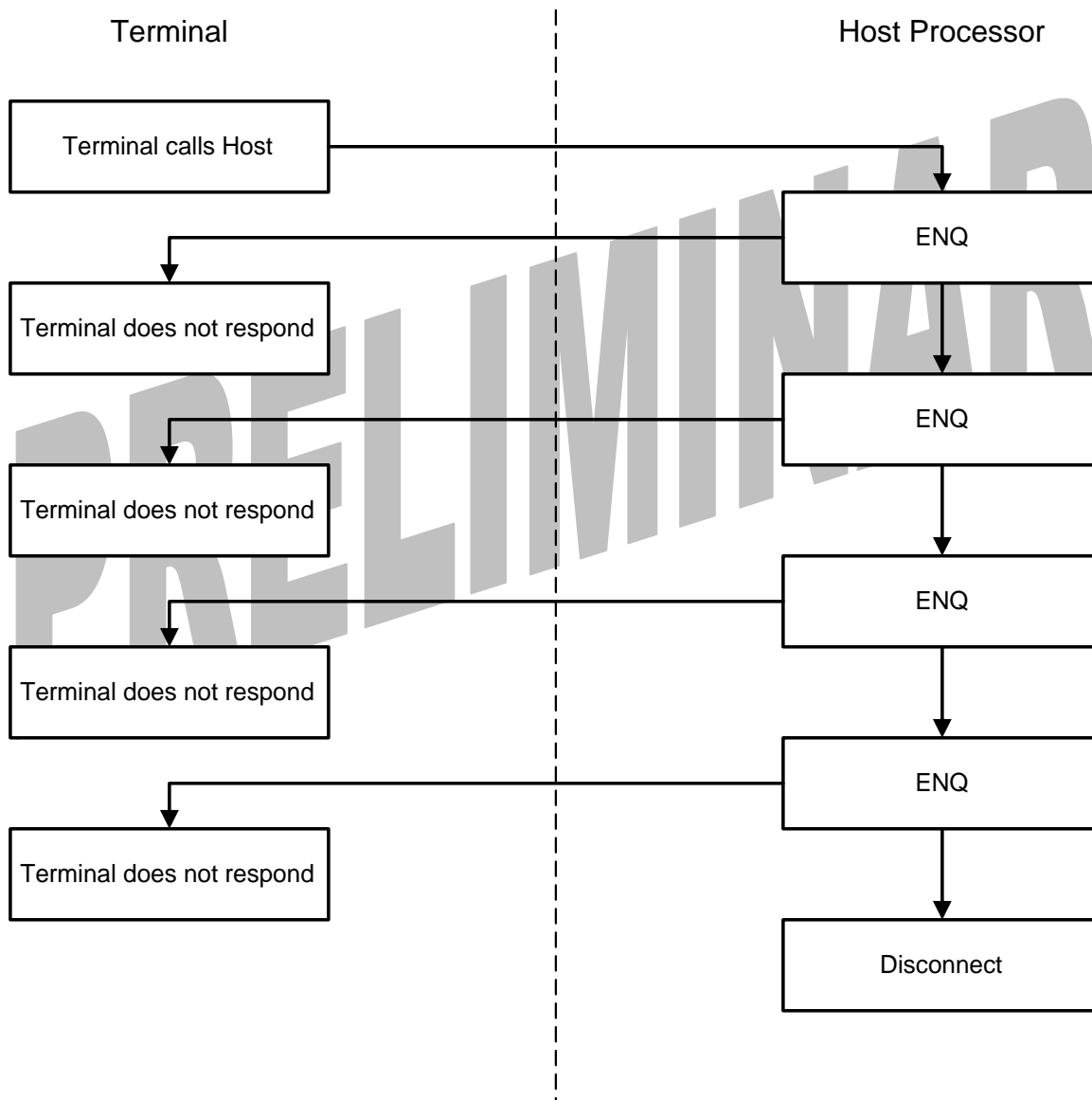
Host Does Not Respond to Request Message

This diagram illustrates the line protocol when the host does not respond to the request message at all. The terminal will not dispense if this happens.



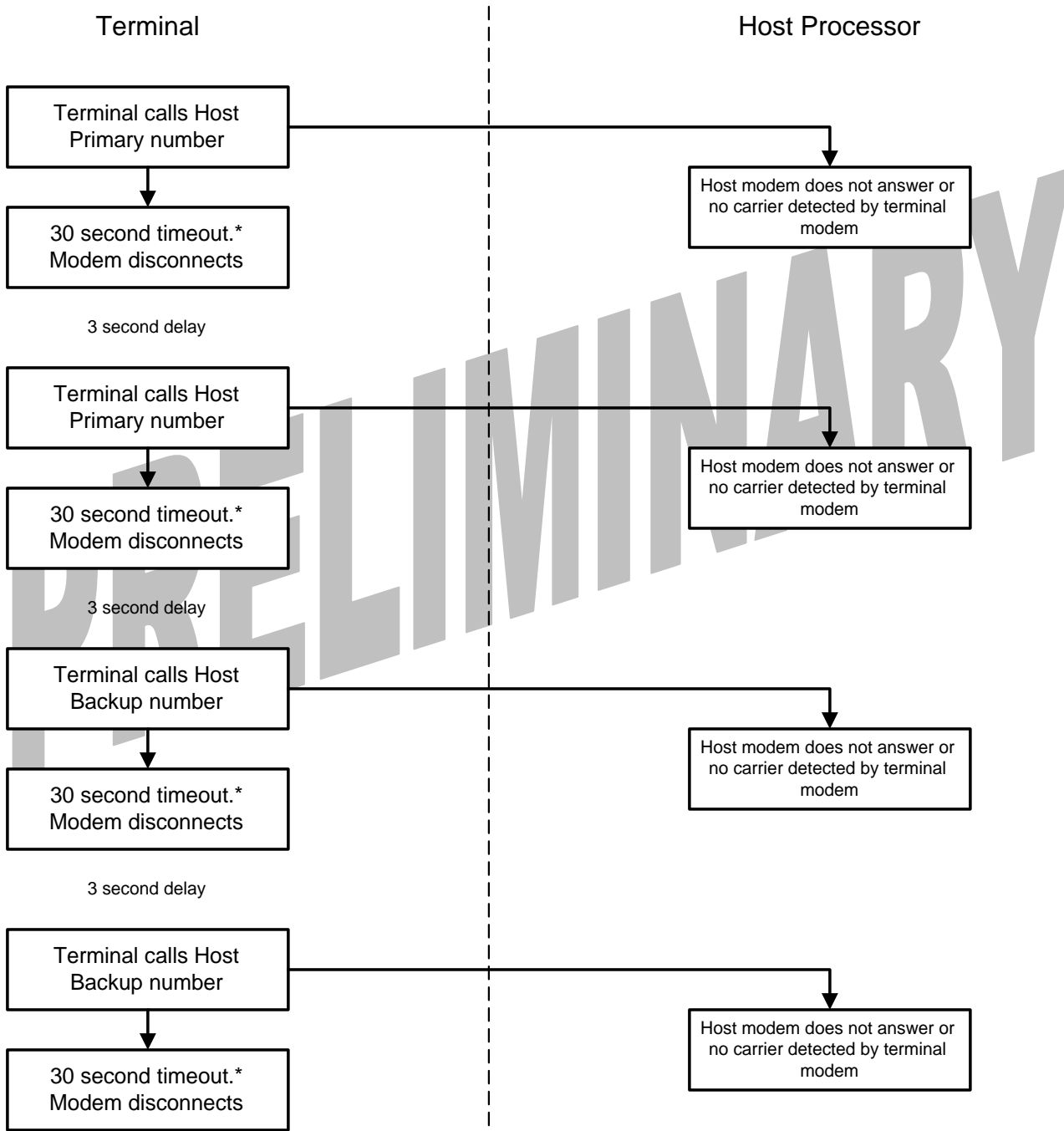
Terminal Does Not Respond to Host ENQ

APPENDIX A

ANSI PIN Block Format

This appendix includes two sections from the American National Standards Institute (ANSI) document titled *American National Standard For Personal Identification Number (PIN) Management and Security X.9.8*. This document describes, among other things, the techniques used to secure transmissions of customer PINs over insecure communications pathways. It is presented as a reference only.

3.7.2.2.2 Clear-Text PIN Block Format

The PIN is assumed to consist of 4-12 decimal digits and *shall* be entered by a customer, in sequence as specified by Section 3.5.1.2, with the first digit entered referred to as digit 1 and the last referred to as digit N.

The clear-text PIN format specified *must* be used in interchange and may be used in the terminal to acquirer segment of the network. Bit positions are specified based on numbering the bits in the DEA input block as in Section 3.7.2.2.1.

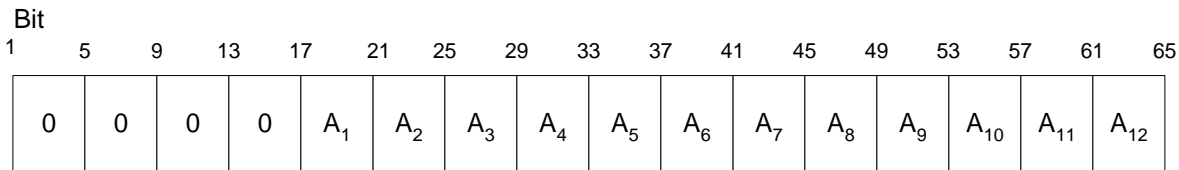

Next, the PIN and account number blocks are Exclusive OR'd before assembled in the DEA input register.

When the customer's account number is not available, other cryptographic techniques should be used to protect the PIN. Appendix F (ANSI X.9.8) illustrates one such method.

Any network or interchange node having access to the clear-text PIN block (i.e., during a decryption/re-encryption or during a PIN verification) should reject transactions having any of the following:

- a. Control field value of other than 0000
- b. A PIN length entered field of value less than 4 or greater than 12
- c. Any PIN digit from P₁ through P_N of value greater than 9

This serves as a reasonable check on PIN encryption/decryption processing, but does not serve as any indication of validity of the customer-entered PIN.

3.7.2.2.3 Cipher-Text PIN Format

The formatted clear-text PIN block, defined above, then *shall* be encrypted using the DEA on Electronic Code-Book (ECB) mode as shown in Section 3.7.2.2.1. The 64-bit output cipher block is called the reversibly encrypted PIN (or encrypted PIN).

The encrypted PIN *shall* be transmitted between financial institutions as a 64-bit entity in bit oriented communications, as eight 8-bit bytes in 8-bit transparent character oriented communications, as sixteen characters representing hexadecimal digits (0, 1, ..., 9, A, B, ..., F), or by any other data representation agreed upon by sender and receiver. (Triton Note: The Triton Standard uses 16 hexadecimal digits represented as ASCII characters).

The order of transmission *shall* be for left to right, with respect to the diagram in Section 3.7.2.2.1. For example, in 8-bit transparent communications the first byte transmitted will contain bits 1 through 8 of the DEA output block; the eighth byte transmitted will contain bits 57 through 64 of the DEA output block.

APPENDIX B

MAC Protocol Addendum

The MAC fields implemented in this specification follow the ANSI Standard X9.19 format.

The Triple-DES MAC Algorithm implemented in this specification uses “MAC Algorithm 3 - Padding Method 1” as defined in ISO/IEC 9797-1.

This section describes the actual implementation of the fields in the message.

1. Insert a Field ID ‘^’ into one of the miscellaneous fields in the formatted message. Fill this field with 9 ASCII zero characters.
2. Create an 8-byte buffer in RAM called ‘INPUT’ and fill this block with hex zeroes.
3. Create an 8-byte buffer in RAM called ‘OUTPUT’ and fill this block with hex zeroes.
4. Begin at the STX character of the formatted message.
5. Take the next 8 ASCII characters from the formatted message (include STX first time through) and transfer them to the INPUT buffer. Use all characters up to and including the ETX. If less than 8 characters are available, pad the remaining position(s) with Binary zeroes.
6. Exclusive-OR the OUTPUT buffer with the INPUT buffer and store in the INPUT buffer.
7. Encrypt the INPUT buffer using DES, or Triple-DES if Triple-DES MAC is enabled and this is the last block(see Figure B1), with the MAC working key(s), MK1 and MK2, and store in the OUTPUT buffer.
8. Repeat steps 5 through 7 until the end of the message is reached (ETX).
9. Discard the right-most 32 bits of the OUTPUT buffer. Convert the remaining 32 bits into ASCII characters, 4 bits at a time to produce 8 ASCII characters.
10. Insert an ASCII space character (20h) after the fourth character.
11. The format of the string should be as follows: ‘XXXX<sp>XXXX’, where X is a hexadecimal ASCII character (0-F).
12. Insert this 9 character string in place of the 9 ASCII zeroes in the Field ID ‘^’ created in step 1.
13. Calculate the LRC of the message with the MAC field in place.

MAC Field Use

When enabled, the terminal will send the MAC field with all message requests except Configuration Table Download request, and will expect them in all message responses except Configuration Table Download response. If the terminal receives an invalid MAC field in a response message, it will immediately perform a Configuration Table Download on a separate call to update the MAC and/or COMMS key. If the failed MAC was contained in a Transaction Response Message and a withdraw or purchase was performed, a reversal will follow the Configuration Table Download, and if a withdraw was performed, no cash will be dispensed in this case.

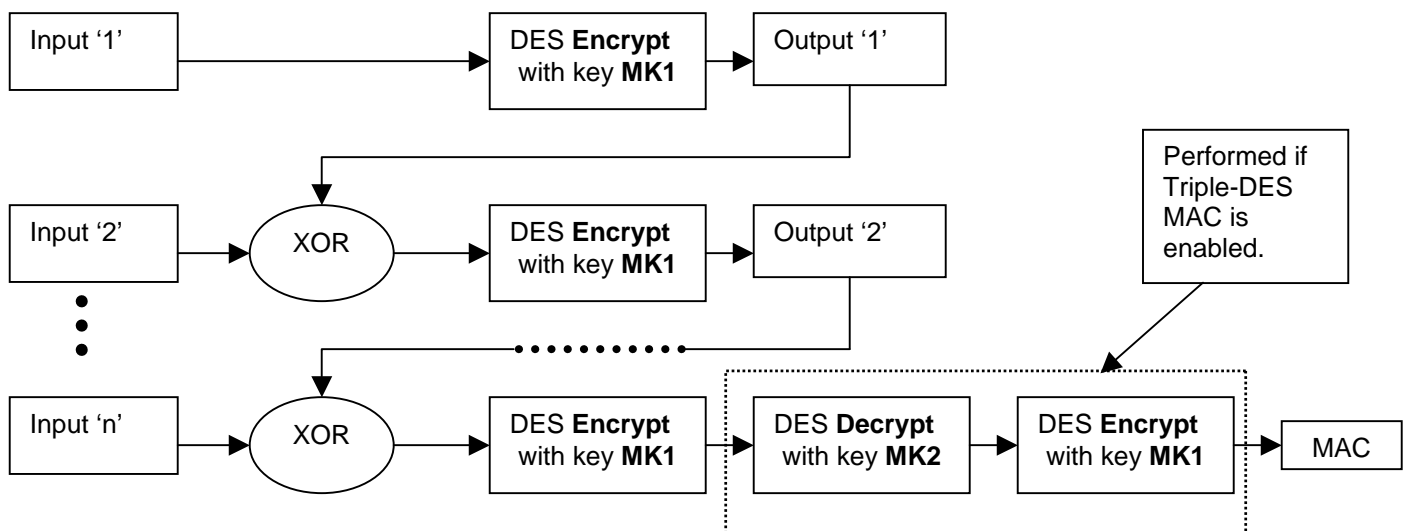
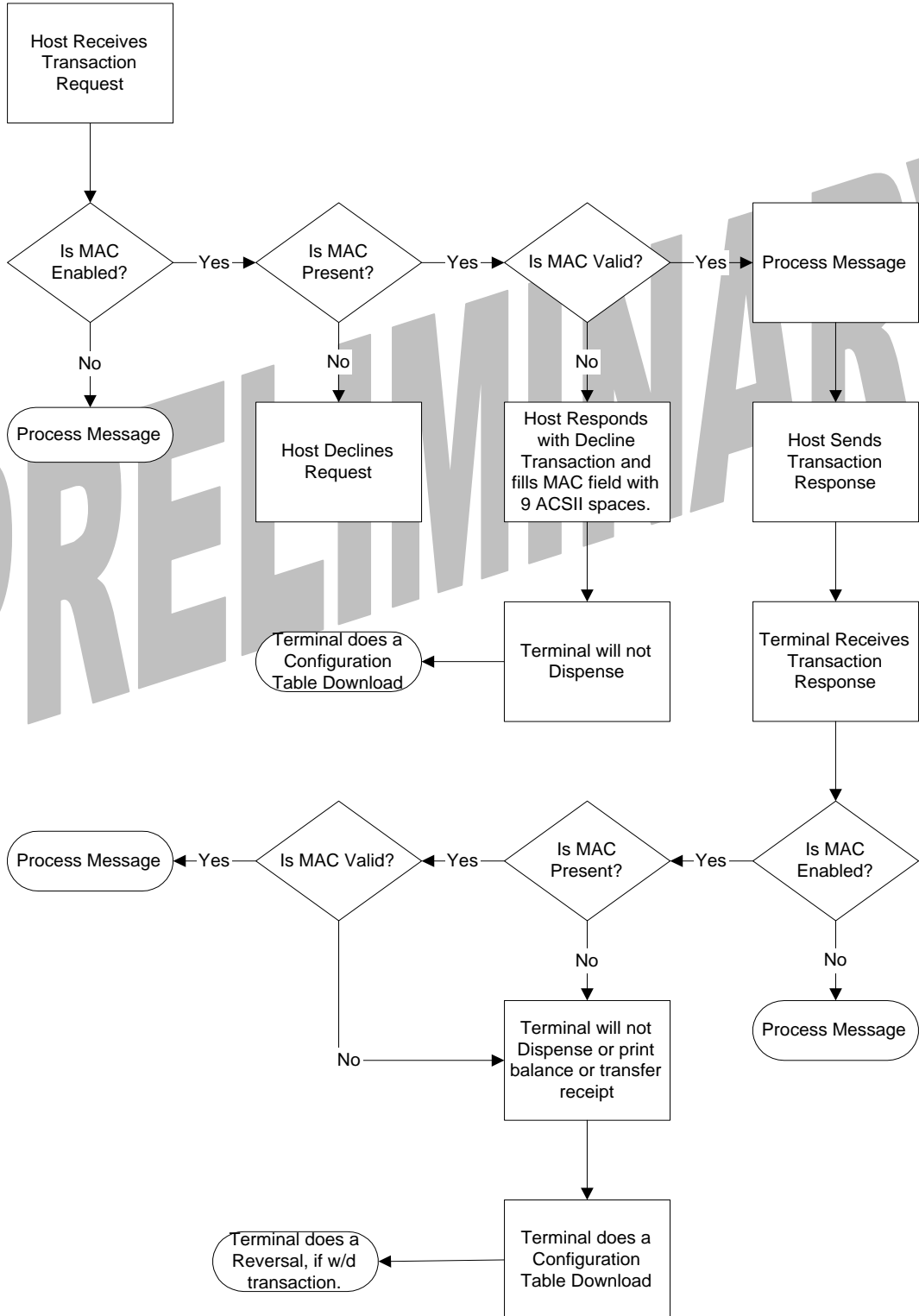


Figure B1 – Triple-DES MAC Algorithm

APPENDIX D

Triple-DES Encryption of the PIN Block

Triple-DES (3DES) encryption/decryption (as specified in ANSI X9.52) is a sequence of DES encryption/decryption operations as shown in diagram 1 and diagram 2 below. 3DES is highly secure and uses two independent 64-bit block keys, $K1$ and $K2$. Single-DES is less secure and is achieved when $K1$ and $K2$ are equal ($K1 = K2$). $K1$ and $K2$ are obtained by sending both the Encrypted PIN-Key 1 ('~') and Encrypted PIN-Key 2 ('{') FIDS in a response message. The Encrypted PIN-Key's are decrypted using the Master Key, resulting in $K1$ and $K2$. The Clear-Text PIN Block Format and Cipher-Text PIN Format are the same for both Single DES and Triple DES. See APPENDIX A for a description of the PIN Block Format.

The presence of only the Encrypted PIN-Key 1 ('~') in a response message will cause 3DES capable terminals to store $K2$ with the value of $K1$, and set the Encryption Mode Flag (EMF) and the '[' FID to zero (0). The presence of both the Encrypted PIN-Key 1 ('~') and Encrypted PIN-Key 2 ('{') will store $K1$ and $K2$ with separate values and set the EMF and the '[' FID to two (2), **even for equal Key values**. When the Key values are equal ($K1 = K2$) in a 3DES capable terminal, Single-DES encryption/decryption is achieved by performing the 3DES encryption/decryption scheme. Table 1 summarizes the '[' FID and EMF.

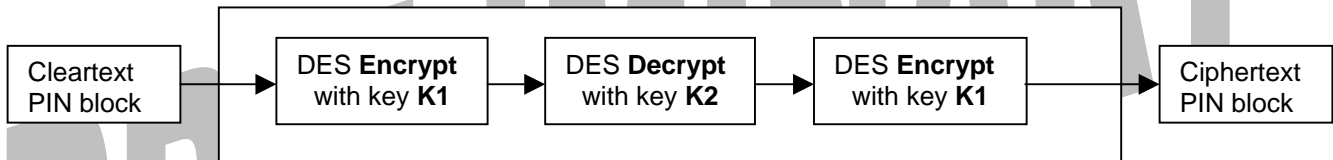


Diagram 1 - 3DES Encryption

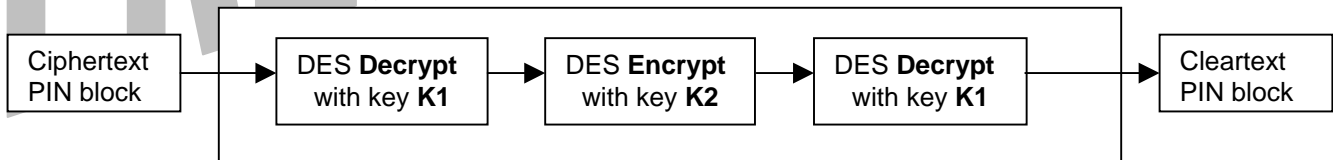


Diagram 2 - 3DES Decryption

APPENDIX E

Encryption Key Sets

For Triton terminals that support multiple host processors, each host processor is assigned one encryption key set. The terminal parameters for each host processor include, but are not limited to, terminal id number, primary and backup host phone numbers, and master and working encryption keys. An encryption key set consists of three pairs of working keys and three pairs of master keys. Each pair of working keys consists of a left and a right block that is used for either Single-DES or Triple-DES encryption of a PIN-Block, MAC message, or DATA message. The PIN, MAC, and DATA master keys are used for encryption and decryption of the associated PIN, MAC, and DATA working keys. The working keys left and right blocks are decrypted as shown in diagram E2 and diagram E3. The Working keys are transmitted to the terminal in encrypted form by using the appropriate FID as a miscellaneous field in a configuration download message. The Master keys are manually entered or electronically injected at the terminal. The FID's are shown in Table E1.

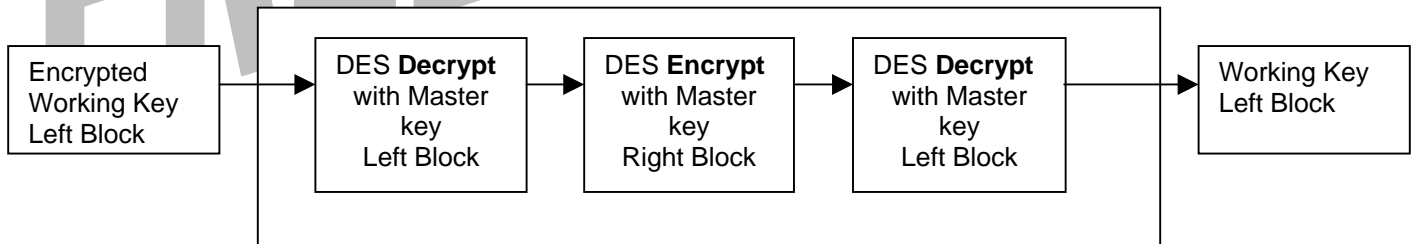


Diagram E2 – Working Key Left Block decryption.

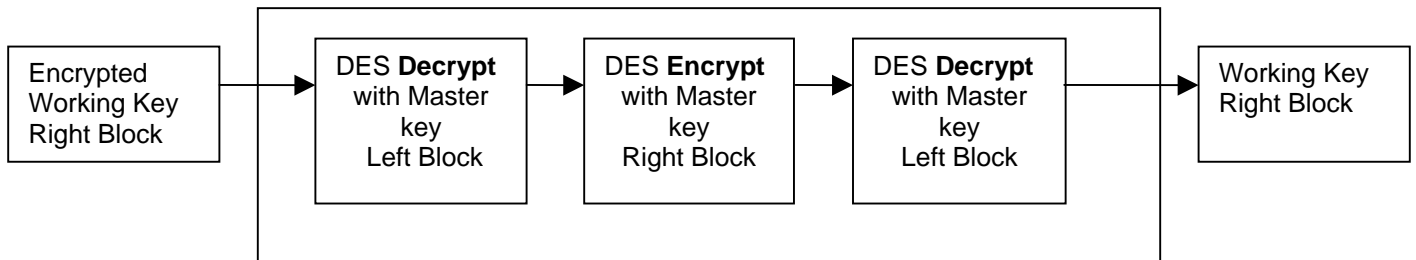


Diagram E3 – Working Key Right Block decryption.

APPENDIX F

ANSI 16-bit CRC

This section describes the implementation of the CRC-16 (ANSI) routine.

1. Insert a FID 'ub' into a miscellaneous field in the message and initialize the 4 ASCII Characters to ASCII zero (0x30) characters.
2. Calculate the CRC on the message excluding the STX, ETX, and LRC (in dial-up).
3. Convert the 2-byte CRC into 4 ASCII characters and insert these in place of the 4 ASCII zeros (0x30) of the message in the order of MSB to LSB.
4. Upon the receipt of the message, the FID 'ub' will be searched for and the 4 ASCII characters representing the CRC-16 value will be extracted and replaced by 4 ASCII zeros (0x30).
5. Recalculate the CRC on the message excluding the STX, ETX, and LRC (in dial-up).
6. Compare calculated CRC with the extracted CRC from the original message.

Appendix G - EMV

Mapping of EMV Data Elements to Existing Fields or FIDS

Some of the data elements required by an issuer to process an EMV transaction map to existing fields or FIDS in the Triton Standard communication protocol. All other fields will be encoded as data in the 'ud' FID as Tag-Length-Value elements or data in the 'uh' FID as TSEMVID-Length-Value elements. However, these EMV data elements that have functionally equivalent fields or FIDS will instead continue to be transported as such, instead of being data in the 'ud' or 'uh' FIDs. The following table shows which EMV data elements can be found in which existing fields or FIDS.

† Please note that if the EMV Transaction Sequence Counter tag (9F41) appears in the 'ud' FID, the value found in that FID is the definitive tag 9F41. In such a case, the sequence number found in the Triton Standard Sequence Number message field is not the EMV Transaction Sequence Counter tag (9F41). Instead, the EMV Transaction Sequence Counter holds a separate, EMV-compliant sequence number, incremented only for EMV transactions, while the Triton Standard Sequence Number field holds the usual sequence number, incremented for every transaction. These two sequence counters will almost always have different values.

Please note that if EMV data is sent from the terminal in a transaction request message in the 'ud' FID, the transaction response message must contain a 'ud' FID with, at minimum, tag 8A for the transaction to be approved.

Encoding of Other EMV Data Elements

Other EMV data elements present in a message will be encoded into the 'ud' or 'uh' FIDs. Data elements specified in the EMV standard that are assigned unique tags will be packed into the 'ud' FID (Encoded EMV data block). Data elements specified in the EMV standard but not assigned a tag will be packed into the 'uh' FID (Encoded EMV untagged-data block).

Encoded EMV data block ('ud' FID)

The data that follows the 'ud' FID is of variable length and contains zero or more data elements encoded according to Basic Encoding Rules—Tag-Length-Value (BER-TLV). See ISO/IEC 8825:1990, ISO/IEC 7816-4:1995 Annex D, and EMV 2000 Book 3 Annex B for a more complete and official description of this format. Information presented here is a summary of important points from these documents and is included for convenience only.

Encoded EMV untagged-data block ('uh' FID)

The data that follows the 'uh' FID is of variable length and contains zero or more data elements encoded according to a scheme identical to the Basic Encoding Rules—Tag-Length-Value (BER-TLV) scheme. However, the identifiers (TSEMVIDs) used in this scheme (instead of tags) are proprietary to Triton's communication specification. **Note:** It is important for any host processing this block to extract these data elements before sending them anywhere. The TSEMVIDs are not specified in the EMV standard and are not meaningful anywhere outside of the Triton Standard communication scheme. See table EMV-1.1.2 for a listing of these TSEMVIDs. TSEMVIDs are encoded using the same rules that cover the encoding of the tag field in BER-TLV.

Basic Format

BER-TLV data elements are each represented with three fields, a tag, a length, and a value. The tag field uniquely identifies the data element. The length field specifies the length in bytes of the value field. The value field holds the actual data element bytes. The following description of these fields apply *before* encoding as 7-bit ASCII hex digits for packing into a Triton communication message.

Tag

For the purposes of this specification, tag fields will always be one or two bytes, although they are not restricted to such by ISO/IEC 8825:1990. Values 0x00 and 0xFF are not considered valid tags, as per ISO/IEC 7816-4. Tags code a Class, Type, and Number; see table B-1 in Annex B of EMV 2000 Book 3 for the coding scheme of a tag. As shown in the table, if the least significant 5 bits of the first byte of the tag are 1, the tag is a two-byte tag. Otherwise, it is a one-byte tag.

Defined tags also carry with them an implied format of the encapsulated data element. See EMV 2000 Book 3 Annex A for a table of defined tags and associated data formats defined by EMV, as well as documentation for individual payment systems that may define their own, issuer-specific tags.

Length

For the purposes of this specification, length fields will always be one, two, or three bytes, although they are not restricted to such by ISO/IEC 8825:1990. The length field specifies the length in bytes of the following value field. Lengths of 0x00 are allowed and indicate the absence of a value field.

If the most significant bit of the most significant byte of the length field is 0, the length field is one byte and the remaining seven bits encode the length value (0-127). If the most significant bit of the most significant byte is 1, the length field is more than one byte and the remaining seven bits encode the number of bytes that follow the most significant in the length field. The subsequent bytes together represent an integer that specifies the length in bytes of the value field.

Value

The value field consists of zero or more data bytes as specified in number by the length field. These bytes represent the actual data of the data element.

Appendix G - EMV

Packing of TLV Encoded Data Elements in the 'ud' FID

TLV encoded data elements will be packed into the data of the 'ud' FID with no separation. All bytes of TLV encoded data elements, when packed into the data of the 'ud' FID, will be represented as ASCII encoded hexadecimal digits, requiring two digits to represent a byte, effectively doubling the size of the data. This is necessary to keep message formatting characters, such as the field separator (0x1C) and end of text (0x03) from being included in the 'ud' FID data. The length field of the TLV encoded data elements will reflect the size of the value field before it is encoded into ASCII hex digits so care must be taken in parsing the elements. Several examples follow for clarity.

Packing of Untagged Data Elements in the 'uh' FID

Untagged data elements defined in the EMV standard, encoded using a TSEMVID, length, and value, will be packed into the data of the 'uh' FID with no separation. All bytes of the encoded data elements, when packed into the data of the 'uh' FID, will be represented as ASCII encoded hexadecimal digits, requiring two digits to represent a byte, effectively doubling the size of the data. This is necessary to keep message formatting characters, such as the field separator (0x1C) and end of text (0x03) from being included in the 'uh' FID data. The length field of the encoded data elements will reflect the size of the value field before it is encoded into ASCII hex digits so care must be taken in parsing the elements.

EMV Example 2

A more complicated example with a three-byte length is shown here. Note the encoding of the length 289 as 0x820121, forming three bytes 0x82, 0x01, and 0x21, yielding the eight hex digits 0x38, 0x32, 0x30, 0x31, 0x32, and 0x31. The first and most significant byte, in binary, is 10000010_b , meaning that this length is a multi-byte length field (most significant bit is 1) and there are two bytes following in the length field (remaining bits code the number 2). The remaining bytes, 0x01, and 0x21 code the number of bytes in the value field by forming the number 0x121 in hex, or 289 in decimal.

Appendix G - EMV

EMV Elements to be Included in Messages

While, theoretically, any EMV data element may be sent or received to process an EMV transaction, hosts should typically expect certain common fields to be included in transaction requests, transaction responses, and transaction reversals. These common fields are listed here. This is by no means an exhaustive list of all possible EMV data elements that can appear in messages, so hosts should be prepared for any defined EMV tag. Any tag not available to the terminal may not be sent, so hosts should be prepared to handle missing data.
